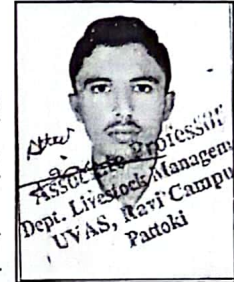

If a candidate finds any discrepancy in the Result Intimation or desires correction in any of the particulars, he/she may contact the Board within 30 days after declaration of the result. Any entry appearing in it does not itself confer any right or privilege independently for the grant of proper certificate, which will be issued under the Rules / Regulations.
- (iv) Candidate intending to apply for re-checking of his/her paper/s may apply Online within 15 days after declaration of the result.
- (v) For the purpose of improvement of grade/marks, a candidate will be provided four examination opportunities in current/prevalent syllabi within a period of three years after having passed the SSC or HSSC Examination, in the same subjects/group in which he/she previously passed the examination subject to the condition that he/she has not attained the higher qualification during this period. However, it will be the choice of a candidate whether he/she appears for improvement of marks in any subject/s or Part I or Part II or as whole with the condition that the candidate can avail these four chances mentioned above till the improvement of the actual result within three years. Once the result of the candidate is improved, he/she will not be allowed to appear again. However, the candidate appearing to improve their overall Grade "E" or "D" are allowed to avail four chances within three years till the achievement of overall Grade "C" (50% marks).
- (vi) Other rules of improvement currently in vogue in all Boards of the Punjab will remain the same.
