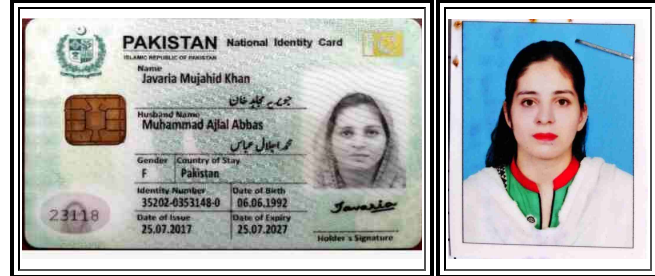

IMPORTANT NOTE:

- o Production of original valid Computerized National Identity Card (CNIC) for the purpose of appearing in the written examination / test is mandatory.
- o However, in case of non-availability of original valid CNIC, a candidate may be allowed provisionally by the Venue Incharge of the centre on production of any one of the following documents:
 - i) Original CNIC which expired not more than six months prior to the date of examination.
 - ii) Original valid passport.
 - iii) Original Computerized Domicile Certificate bearing candidate's picture.
- o The above mentioned provisional permission given by the Overall Incharge / Venue Incharge shall be subject to undertaking in writing by the candidate that he/she will produce original valid CNIC at the

- time of interview, failing which his/her candidature shall be cancelled.
- **Reporting Time at the Examination Centre is 30 MINUTES before attendance time.**
 - **No entry will be allowed in the Examination Centre after 20 minutes of attendance time and no excuse will be accepted.**

- ☆ امیدوار کے لیے لازم ہے کہ امتحان میں شرکت کے لیے اصلی اور کارآمد قومی شناختی کارڈ پیش کرے۔
- ☆ اگر امیدوار کے پاس اصل کارآمد قومی شناختی کارڈ موجود نہیں ہے تو انچارج امتحانی سنٹر مندرجہ ذیل میں سے کسی ایک دستاویز پیش کرنے پر اس کو مشروط اور عارضی طور پر امتحان میں شرکت کی اجازت دینے کا مجاز ہوگا:
- (i) اصلی قومی شناختی کارڈ جو کہ امتحان کی تاریخ سے چھ ماہ سے زیادہ زائد المیعاد نہ ہو۔
- (ii) اصل اور کارآمد پاسپورٹ۔
- (iii) اصل کمپیوٹرائزڈ ڈومیسائل جس پر امیدوار کی تصویر ہو۔
